Educational Program - Patient Care Experience | Since: 10/16/2013 | Status: Resolved

Citation 2

Patient Care/Stable Patient Population and Diverse Resident Patient Care Experiences in the Family Medicine Center [IV.A.5.a).(2).(c).(iii).(a)]

The program must document the availability of a stable patient population in the FMC of sufficient number and variety to provide all residents with an adequate experience in the comprehensiveness of the specialty. It should be documented that each resident has experience with all age groups having adequate gender distribution, in volumes sufficient to achieve competency in all aspects of family medicine.

The Committee was not able to determine compliance with the requirement. Specifically, based upon peer judgment, the Committee determined that the percentage of visits by patients less than 10 years of age provided in the PIF is inadequate at 6.1%. (Program Information Form, pp. 71)

Evaluation of Residents | Since: 02/09/2015 | Status: Resolved

Evaluation V.A.2.a)

The faculty must evaluate resident performance in a timely manner during each rotation or similar educational assignment, and document this evaluation at completion of the assignment. (Core)

The information provided to the Review Committee did not demonstrate substantial compliance. Specifically, the annual data provided reflects only 40-59% of faculty complete written evaluations of residents within 2 weeks following each rotation or educational experience. Additionally, information from both the 2013 and 2014 Resident Survey in the area of Evaluation reflect potential non-compliance that needs to be addressed. (Annual Data, Resident Survey)

Curricular Development | Since: 02/09/2015 | Status: Resolved

Curriculum Organization and Resident Experiences IV.A.6.a).(5)

Residents must provide care for a minimum of 1650 in-person patient encounters in the FMP site. (Core)

The information provided to the Review Committee did not demonstrate substantial compliance. Specifically, the annual data provided reflects one graduating resident achieving only 1584 visits, and the seven (7) remaining graduates each reporting exactly 1650 visits respectively. The reporting as totaling exactly 1650 visits for each of the remaining residents suggests the possibility of inaccurate data for the others. (Annual Data)

Duty Hours and Working Environment | Since: 02/09/2015 | Status: Resolved

Resident Duty Hours in the Learning and Working Environment VI.A.4.b)

Educational objectives of the program must not be compromised by excessive reliance on residents to fulfill non-physician service obligations. (Core)

The information provided to the Review Committee did not demonstrate substantial compliance. Specifically, information from both the 2013 and 2014 Resident Survey in the area of Education Content reflect potential non-compliance in areas of balanced education and service obligations that needs to be addressed. (Resident Survey)

Scholarly Activities | Since: 02/09/2015 | Status: Resolved

Faculty II.B.5.

The faculty must establish and maintain an environment of inquiry and scholarship with an active research component. (Core)

The information provided to the Review Committee did not demonstrate substantial compliance. Specifically, information from both the 2013 and 2014 Resident Survey in the area of Faculty reflect potential non-compliance in areas of faculty interest in the program, instruction, etc. (Resident Survey)

The Review Committee identified the following areas for program improvement and/or concerning trends:

Educational Content

The committee cautions the program to closely monitor the experiences of the residents in maternity care. With a wide fluctuation of deliveries recorded, the committee wants the program to ensure that all residents have adequate exposure to maternity care.
